

California Natural Gas Vehicle Coalition

Who we are: The California Natural Gas Vehicle Coalition is an industry trade association dedicated to promoting natural gas as a clean, low-carbon alternative transportation fuel for California. Members of the Coalition include vehicle and engine manufacturers and retrofitters, natural gas utilities, fuel providers, builders and owners of fueling stations, industry equipment manufacturers, and fleet users of natural gas vehicles.

The Coalition supports the use of both compressed natural gas (CNG) and liquefied natural gas (LNG) in a full range of vehicle types, from light-duty passenger vehicles to medium- and heavy-duty vans, trucks and tractors.

What we do: The California Natural Gas Vehicle Coalition represents the natural gas vehicle industry in Sacramento and around the state to support policies that promote the use of natural gas as a transportation fuel.

We work at the State Legislature, the California Air Resources Board, the California Energy Commission, local governments, regional Air Pollution Control Districts, and the state's major ports to educate policy makers about the economic and environmental benefits of natural gas as a vehicle fuel and to protect the interests of the natural gas vehicle industry.

The Coalition works closely with the environmental community and state and local agencies as well as industry members to advance policies that benefit the natural gas vehicle industry, including by sponsoring legislation and advocating for the industry in regulatory proceedings.

Why it matters: For a century, petroleum has dominated the transportation fuel supply of California and the US. Whether it is air pollution and climate change, fuel supply and security, or simply the cost of the fuel itself, California must reduce its petroleum dependence.

Natural gas provides a path to reduced petroleum dependence today. For 20 years it has demonstrated lower pollutant emissions than gasoline and diesel and is now recognized as a low carbon fuel. As the world's oil reserves shrink, important new natural gas supplies are being discovered in the US. And the pump price of natural gas is consistently and significantly lower than gasoline and diesel fuel.

About This Directory

The California NGV Coalition Natural Gas Fueling Station Directory is designed to help you locate and use public natural gas fueling sites throughout the state as well as in Arizona and Nevada. The Station Location Index divides California into three sections – Southern, Central and Northern – and arranges stations alphabetically by city within each section. Numbers next to each station entry correspond to the area maps at the beginning of each section.

The directory is updated as needed. But for the most current information on availability and prices of natural gas in California and across the US, you may also want to consult the Coalition's website www.cngvc.org and click the "Find fueling stations" link.

To the best of our knowledge, information in this directory was accurate at the time of publication. However, we cannot guarantee continued accuracy or accept responsibility for errors and omissions. We recommend that drivers contact the operators of unfamiliar sites prior to use for current access and equipment information.

Using California's Natural Gas Fueling Station Network

As with conventional fueling stations, hours of access, equipment, payment methods, and on-site assistance vary from site to site. All sites in this directory are designated "public" by their operators. However, in some cases access is limited (to daytime business hours, for example), and in most cases you will need to establish an account with the operator to fuel at its sites. Various fuel marketers operate customer service and information lines that can help NGV users obtain fuel. Some provide emergency roadside fueling or offer mobile fueling service when it's available (at a temporary job site, for example). Following is a list of contact numbers for operators of multiple stations. Contacts for singlestation operators are provided with the station listings.

Natural Gas Vehicles: Private Sector and Public Policy Equal Progress

Natural gas as a transportation fuel had some of its earliest success in California, where vehicles and fueling stations first began appearing more than 20 years ago. Yet during that time natural gas vehicles have made even greater progress in many other parts of the world. In the last five years alone the number of NGVs worldwide has exploded from 2.5 million to almost 9 million.

From the heart of Europe to the emerging economies of South America and the far east, natural gas is being recognized as a low-cost, low-emission, safe and secure transportation fuel. And the development of biomethane from landfills, dairies, feedlots and wastewater treatment plants is turning a fugitive greenhouse gas into a captured and renewable near-zero carbon fuel.

NGV Industry Hard-Working and Diverse: Progress like this doesn't happen by good luck, especially when it must overcome a very powerful and entrenched petroleum-based transportation system. In California it has been forged by the hard work of forward-thinking companies like natural gas utilities Southern California Gas Company and San Diego Gas and Electric, by fuel providers like Clean Energy, Trillium and Pinnacle, and by providers of industrial equipment like Cryostar and Weaver Inc.

American Honda has been a worldwide leader in the production of the Civic GX passenger sedan, and over the years Ford and GM have sold numerous CNG models in the US. Westport Innovations and Emission Solutions are industry leaders in the development of heavy-duty natural gas engines, and BAF Technologies has played a critical role in expanding light-duty vehicle availability through conversions of a variety of Ford models. Finally, the NGV industry is indebted to innovative companies like Waste Management, UPS, Super Shuttle and Yellow Cab of San Francisco that have made a strong commitment to natural gas vehicles in their fleets.

Policies Matter: For years the California Natural Gas Vehicle Coalition has stressed that public policy has an essential role to play in creating a lower-polluting, more diverse and reliable transportation fuel system. Many other countries have adopted policies that account for the full economic and environmental cost of petroleum and thus incentivize the adoption of cleaner, lower cost fuels like natural gas.

There is a reason why 20 different automakers produce natural gas vehicles for the world market; why GM alone makes 18 natural gas models through alliances with other automakers; why Austrians can choose from 28 factory model NGVs and 50 more retrofit models; why Sweden has developed a large-scale fueling infrastructure to carry near-zero carbon biomethane directly to the gas tanks of NGVs. These countries have implemented public policies to promote the use of natural gas and NGVs.

Good News in California: In recent years the California Legislature, Governor Schwarzenegger and key regulatory agencies

have focused their attention on the need for alternative fuels and have adopted an array of policies designed to transform the state's transportation fuel system. Actually, the effort began almost 20 years ago when California's major public utilities implemented a low emission vehicle program to promote the use of natural gas and electricity. Since then the policies and programs adopted to promote alternative fuels like natural gas have included:

• **SCAQMD Fleet Rules:** In 2000 and 2001 the South Coast Air Quality Management District adopted rules requiring seven vehicle fleets, including refuse trucks, taxis and shuttles, transit and school buses, and light-duty and heavy-duty public fleets to transition into low-emission alternative fuel vehicles. These rules helped kick-start and sustain the California NGV market.

• **Moyer program:** Administered by the Air Resources Board and local air districts, the program named to honor air quality pioneer Carl Moyer provides funding to encourage heavy-duty vehicle owners to reduce their diesel emissions below required levels, including by shifting to natural gas engines.

• **HOV Lane Access:** Since 1999 the state has allowed single occupant natural gas vehicles to use HOV lanes. The program has proved to be one of the strongest incentives to buy a natural gas vehicle, especially in urban areas with slow commutes.


• **State Alternative Fuels Plan:** Pursuant to AB 1007 enacted in 2005, the CA Energy Commission prepares the first comprehensive set of strategies and actions for the state to increase its use of alternative non-petroleum fuels. The study finds that natural gas reduces greenhouse gas emissions on a life-cycle basis between 21% and 30%.

• **AB 32:** In 2006 the Legislature and Governor enact the nation's first greenhouse gas emission reduction law, requiring that GHG emission levels be reduced to 1990 levels by 2020.


• **Port Clean Air Action Plans:** The state's three major ports – Los Angeles, Long Beach and Oakland – adopt clean air plans to reduce diesel emissions. Conversion of port trucks to clean-burning natural gas is a key component of the plans.

• **Low Carbon Fuel Standard:** One of the ARB's first major actions under AB 32 is to adopt a standard requiring that all transportation fuels have at least 10% lower carbon content, on a life-cycle basis, than gasoline and diesel by 2020. Natural gas is found to be LCFS-compliant upon adoption, and renewable biomethane has the lowest carbon content of all fuels analyzed.

• **AB 118:** In 2007 the Legislature and Governor approve about \$100 million in annual funding to support development and commercialization of alternative fuels and alternative fuel vehicles that will help the state reduce petroleum dependence and meet its AB 32 goals.





• **Convenient:** This Directory identifies more than 150 natural gas fueling stations open to the public in California, Arizona and Nevada. California leads the nation in ready access to natural gas, and the state's fueling infrastructure continues to grow.
